## WHAT'S HAPPENING AROUND WRC AND THE REST OF THE WORLD

A bare-bones report from the Rockville Rotary 8K on July 16th reveals that **Chris Fox** broke the course record by two seconds on a hot and humid night to take the win in 23:40. **Maria Pazarentzos** won the women's race in 28:01, ending a bit of a slump for her earlier in the season. Pazarentzos didn't have an easy race with **Christi Constantin** breathing down her neck the entire race, and finishing 16 seconds in arrears. **Bonnie Barnard-Lopez** took third place, after losing contact with the two leaders at the 3-mile mark. Barnard-Lopez blamed herself for going out too fast, which caused her to fade in the final two miles. **John Dix** ran a 28:34 for an age-group win, and **Bernie Gallagher** finished in 29:34.
