MOESER & GERKEN WIN AT JINGLE BELL; SUMMY CLARKE ON COMEBACK TAKES 2ND by George Banker

The 11th Annual Jingle Bell Run for Arthritis 10K attracted more than 3,000 runners to the starting line at freedom Plaza on Pennsylvania Avenue on Sunday, December 4, 1994.

Last year's winner, Eric Woronick, was coming off a track season at George Washington University and was on the line looking for another win. The winner of last

year's women's title, Christine Constantin, was not in the field.

A relatively slow opening mile of 5:12 saw five runners in the lead pack: Woronick, Eric Desautels, Chuck Moeser (last year's runner-up and top master), Nathan Powell, and Victor Vasquez. Moeser picked up the pace and took the lead through mile number two in 10:20, with Woronick and Vasquez in close contact. Through miles three (15:36) and four (20:53), the trio hung together as Woronick and Moeser took turns leading. Woronick was in the lead through mile five (26:04). As the leaders came down Pennsylvania Avenue to the finish line, with the Capitol in the background, it looked like a repeat win for Woronick. However, Moeser wasn't about to concede anything as he launched a final surge over the last few hundred meters to take the win in 32:15. Woronick took runner-up spot in 32:18, just one second ahead of Vasquez. Powell trailed in fourth with a time of 33:03, with Desautels in fifth in 33:20.

In the women's race Heidi Gerken took the win with a time of 35:31. Second place was taken WRC's Sunny Clarke with a strong 35:56 time. It looks like Clarke is on her way to returning to her sub-35 form of 1993, and that should make for an interesting 1995 season. Kim McLaughlin took third in 36:38, with another WRCer, Teren Block, taking fourth in 37:50. Susan Kinnecombe rounded out the top five in 38:44.

Moeser's 32:15 established a new master's event record. Second master was Marc Rogers in 35:16, with the ever-competitive Faye Bradley's 35:33 taking third and first in the 55-59 age group.

Top female master was Deborah Gebhard in 42:16, followed by Joyce Adams in 42:41. Third place was taken by

KULIK AND BARNARD-LOPEZ TAKE HONORS AT NEW, AND TOUGHER, GREENBELT 20-MILER

The Greenbelt 20-Miler, and its concurrent 10-miler, had a change of venue for 1994 race held on Saturday, December 17. Greenbelt National Park provided a (very) challenging 5 mile out-and-back course--which resulted in the 20-miler being something like running the Langley 8K four times. The popular TGIF restaurant in Greenbelt generously allowed DCRRC to set up registration on their premises to overcome the ban on collecting entry fees on Park Service property.

Ron Kulik established himself as the unbeatable man on the first leg of the race, but the second-place battle between masters runners Paul Peterson and Ric Banning took a little longer to sort itself out, with Peterson prevailing in the end. Kulik's controlled 1:54:54, on what was for him basically a hard training run over a very difficult course, gives an indication that on the right course he may be close to an Olympic Marathon qualifier in 1995. Peterson's masters win in 1:59:34 reemphasizes his position in the top flight of masters competition in the Washington area. Banning's 2:01:20 will be one of his final races in the U.S. before he heads off to Italy--just one of the burdens of being a Navy man. Of the top five runners three were masters--perennial Greenbelt competitor Ben Beach was in fifth place in 2:04:54.

The women's race also had the winner establish herself on the first loop. Bonnie Barnard-Lopez kept up steady 6:30 miles throughout the entire 20 miles, and looked to be running well within herself as she crossed the finish line in 2:09:44. Second place woman, Jennifer Stearns, pulled away from Leslie Minnix-Wolfe and Teren Block in the second half of the race, finishing in 2:14:16, with Minnix-Wolfe and Block taking 4th and 5th respectively in 2:17:20 and 2:17:33.

More than one entrant in the 20-miler dropped down in distance to the 10-miler after they had finished the first leg and had a chance to check out the course and the competition--is that legal?

In the 10-miler, Matthew Boyd took the win with a 54:46 finish, just 15 seconds ahead of Dominique DaLuz in second place. Mark Miller rounded out the top three with a 56:41 finish.

WRC's Chris Stockdale easily won the women's race and took 50+ and masters honors in 80:00. Lisa Kringle's 84:20 was good enough for 2nd, and Susan Dawson edged out Sonya Buchanan 85:22 to 85:26 for 3rd.

Kevin Baur took the 10-miler male masters honors in 63:25, and Bill March (of WRC) took the top 50+ spot in 72:48.
